### FULL MEMBERSHIP

Full members must be engaged in economic development and must be an individual. Groups can qualify under the “Organization” category.

➤ Employee of a CEDO	➤ Corporation (private or public traded)

➤ Employee of Aboriginal Governments	
➤ Employee of Public Aboriginal/Territorial Governments including respective Crown Corporations	
➤ Employee of CFDC (where the Board is 50% Aboriginal)

➤ Employee of Peace Hills Trust / All Nations Trust	
➤ Member of a Métis Local	
➤ Member of a Métis Settlement	
➤ Employee of an Educational Institution who is in the recognized field of study of Business Administration, Public Administration, Business Finance, Business Management, Natural Resources, Community Economic Development and/or Human Resources	

### ASSOCIATE MEMBERSHIP

An Associate member must be an individual

Qualify
➤ Municipal, provincial or federal government
➤ Private Business / Private Consultant / Contractor
➤ Public Bank or Financial Institution
➤ Agencies & organizations
➤ Associations like <i>Alberta Chamber of Commerce</i> unless it complies with full membership criteria
➤ Friendship Centres

## STUDENT MEMBERSHIP

To be eligible to become a Student member, an individual must be enrolled in one of the following fields of study: **Business Administration, Public Administration, Business Finance, Business Management, Natural Resources, Community Economic Development and/or Human Resources.**

**Note:** If one is a student as well as practicing EDO, he/she can have an option of taking a *Full Membership* instead of a *Student* membership, and consequently have voting rights.
